SGISPL has been contracted by Vakrangee Limited, Mumbai for the verification of direct and indirect Greenhouse Gas Emissions in accordance with ISO 14064-3: 2006 as provided by Vakrangee Limited in the GHG Assertion in the form of GHG report covering GHG emissions of the period 01 January 2020 to 31 December 2020.

Roles and Responsibilities

The management of Vakrangee is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the record of GHG emissions.





Conclusion

Vakrangee provided the GHG assertion based on the requirements of ISO 14064-1: 2006. The GHG information for the period 01 January 2020 to 31 December 2020 disclosing emissions of Two Hundred and Seventy Three (273.839) Tonnes of CO2 equivalent are verified by Shamkris to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria. Sharp reduction in the Generation of GHG was observed presumably because of the lockdown and the Covid most of the users were working from home. However, due to the subjectivity involved the consumption of home users is not covered under Scope 2 and thus further lowering the GHG generation.

Shamkris's approach is risk-based, drawing on an understanding of the risks associated with reporting GHG emissions information and the controls in place to mitigate these. Our examination includes assessment, on the test basis, of the evidence relevant to the amounts of disclosures in relation to the organization's reported GHG emissions.

We planned and performed our work to obtain the information, explanations and evidences that we considered necessary to provide a reasonable level of assurance that the GHG emissions for the period between 01 January 2020 and 31 December 2020 are fairly stated.

We conducted our verification with regard to the GHG assertion of Vakrangee Limited which included assessment of GHG information system, monitoring and reporting plan/protocol. This assessment included the collection of evidence supporting the reported data, and checking whether the provisions of the protocol reference, were consistently and appropriately applied.

Auditors took the liberty to assess the emissions purely basis the electricity consumed and electricity generated from Solar Panels only due the nature of activity of Vakrangee. Exclusions claimed were of the branches and the Vakrangee Kendras due to the subjectivity involved at respective locaitons.

In the auditors opinion, the presented GHG assertion

- is materially correct and is fair representation of GHG data and information, and
- is prepared in accordance with ISO 14064-1: 2006 & IS O14064-2:2006 on GHG quantification, monitoring and reporting.

This statement shall be interpreted with the GHG assertion of the Vakrangee Limited as a whole.
