2. Other Voluntary Activities: FY2020-21

Apart from the above, the Company also regularly carries out philanthropic/charity activities through in-kind distribution of perishable gift hampers which are available post festive season, used office equipment's and any other non- cash items.

During FY2020-21, we did an activity named Mission Anaaj wherein we adopted a nearby slums and distributed food grain packets to the households. During the event we gave away 5000 packets of food grains to 5000 households.

Also, during FY 2020-21, Employees from the Human Resource Dept., Admin Dept., Stores Dept. of the Company were engaged in community engagement activities such as distribution of food and other basic essentials in the slum areas. The employees of these respective Dept. were also engaged in community programs during office time and the approximate cost to company involved in these activities is Rs. 3,00,000/- during FY 2020-21.

All the Community Affairs and CSR/ Charity related activities are monitored by the CSR Committee of the Company comprising majority of Independent Directors. Further, the following Departments work closely under the guidance of the Committee:
